While privacy laws prevent me from providing much information about this specific situation, I can share with you that the charges are related to events that are alleged to have occurred in 2008 on the campus of Heritage Middle School. As soon as we became aware of this matter, we contacted WCPSS Human Resources who immediately suspended the teacher and opened its own investigation into the matter.

I want to assure you that our first and foremost concern is the safety of our students. Our school community does not take the trust you place in us for granted. I cannot express how deeply troubled I am by these disturbing allegations.

I ask everyone to be vigilant in protecting our children and to have important conversations with their children about relationships with adults.
